Dear Surrogacy Applicant:

Thank you for considering Our Agency as you investigate the possibility of offering the gift of a baby to an Intended Parent.

Since infertility is an indiscriminate condition, we are in search of women from all walks of life, including all ethnicities, every race, with any hair and eye color, varying physical attributes, academic achievements and/or special talents.

We are here to help make the process a pleasant and fulfilling experience.

**Who we are:**

We are a Surrogacy facilitation agency that helps guide Prospective Parents through the Surrogacy process, from start to finish. Our agency matches Prospective Parents with Surrogates and manages all the complex arrangements associated with a Surrogacy cycle. We are in the business of helping families conceive children that they are unable to conceive on their own due to a wide variety of reasons. We are here to be your "helping hand" throughout your Surrogacy cycle.

Our agency was founded in 2008 and unlike many agencies, is fully registered and licensed by the State of New York. We have a Five Star rating on Google (\*\*\*\*) and have over 1,000 egg donors and surrogates registered in our database.

Our Agency staff emphasizes the importance of confidentiality, sensitivity, communication, and support with our clients. Our agency works with a wide variety of clients, including single, gay, and lesbian Prospective Parents, in addition to traditional couples. With our main office in New York, our Agency works with Prospective Parents throughout the world.

We are currently seeking surrogates Nationwide in the USA.

### **Requirements to Be a Surrogate:**

We do require that our Surrogates possess a strong sense of commitment, the ability to demonstrate integrity and dependability, as well as a genuine humanitarian desire to assist an infertile couple/individual in conceiving.

The minimal qualifications for being a Gestational Surrogate through our agency are:

- **Between the ages of 21-40**
- **Have had at least one, full-term healthy pregnancy and delivery (no more than 5)**
- **Have had no more than 2 c-sections**
- **Have a BMI of 35 or below?**
- **Preferably reside in a surrogacy friendly state. These are: CA, CT, DC, DE, ME, NH, NJ, NV, RI, VT**

**In addition, we prefer that our surrogates are:**

- Healthy, with a healthy lifestyle and a stable home environment.
- Committed to taking meticulous care of her health during a pregnancy.
- Without any family or personal mental or physical health issues that could impede a pregnancy.
- A nonsmoker, without any history of drug or alcohol abuse. Further, the surrogate does not live in a smoking household, and is fully committed to refraining completely from any alcohol use, unauthorized drug use, or smoking throughout the period of conception and pregnancy.
- Committed to maintaining a healthy diet and to taking the necessary prenatal vitamins/minerals according to the physician's instructions/recommendations.
- Within the age and Body Mass Index (BMI) guidelines of the Intended Parents' IVF Center.
- In possession of or able to acquire usable insurance with maternity coverage for a surrogacy.
- Trustworthy and respectful of the Intended Parents' confidentiality and privacy.
- Willing to have regular contact with the Intended Parents throughout the surrogacy journey.
- Willing to carry identical twins, should a single Embryo split into two.

- Financially stable and secure, and not a recipient of government assistance.

### **Compensation:**

Our surrogate base amount ranges from \$32,000 to \$42,500 for a first-time surrogate mother, depending on the state in which you live.

You will also be provided with a monthly allowance, a maternity clothing allowance, and will have all your medical bills and travel expenses covered during your surrogacy journey. Your contract will address provisions for lost wages, childcare, and other out of pocket expenses. These are disclosed in detail on our website and will also be included in your surrogacy contract.

In addition, we offer to surrogate mothers, a \$250 Bonus for qualified surrogate applicants. This bonus is paid after our screening has been completed and there has been an official match is made with Intended Parents.

### **Medical Issues:**

Getting pregnant and carrying a baby has medical risks. Prior to beginning your cycle, it is highly recommended that you thoroughly discuss all potential risks and side effects with your physician. They are also disclosed on our website.

### **Next Steps:**

After reading the above, if you are ready to proceed, we welcome you to register with our agency.

### **To Do:**

1. Complete the application and submit it to our office either electronically (e.g. via computer) or hard copy via the U.S. Mail. It is preferred that you complete the application electronically, if possible.
2. Email or mail us a minimum of four recent photos, as well as a minimum of three childhood photos, of yourself.
3. Email or mail us a copy of your driver's license or other valid photo identification card. This document will be kept confidential and will not be shared with any other parties - we only use it to verify your identity.
