# Sample 12-Month Timeline Planner for Intended Parents

The surrogacy journey is an exciting and emotional process that typically takes 12–15 months from start to finish. This sample 12-month timeline planner for intended parents provides an organized view of the major milestones and steps involved in a standard surrogacy program with Surrogacy4All. Please note that individual timelines may vary depending on personal, medical, and legal circumstances.

## Month 1-2: Initial Consultation and Agency Sign-Up

- Research and select a reputable surrogacy agency such as Surrogacy4All.

- Review and finalize all legal documents to establish parental rights and obligations.
- Execute contracts after both legal teams approve the terms.

#### Month 8–9: Embryo Transfer Preparation

- Coordinate with the fertility clinic to create and transfer embryos.
- Surrogate starts medications and monitoring as per doctor's protocol.
- Embryo transfer takes place; two-week wait period for pregnancy confirmation.
- Celebrate positive pregnancy test results and confirm heartbeat via ultrasound.

#### Month 10-11: Pregnancy Care and Support

- Regular OB appointments and ultrasound check-ups for surrogate.
- Provide emotional and logistical support to your surrogate throughout pregnancy.
- Start planning delivery arrangements and travel logistics for the birth.
- Keep communication consistent through agency updates and milestone reports.

### Month 12: Delivery and Post-Birth Legal Process

- Arrive at or near the surrogate's delivery location around due date.
- Be present (if possible) for the birth of your baby.
- Complete legal paperwork for parentage establishment and birth certificate.
- Celebrate and take your baby home your surrogacy journey is complete!
